What's Included in the Investigation and Report

The City Engineer's Office, Land Development Division investigates the involved property to determine if it is subject to quiet title action under <u>Section 771.010 of the Code of Civil Procedures</u>. If the property meets all of the requirements, the future street or future alley will be relinquished subject to <u>Section 771.020 of the Code of Civil Procedures</u>. Property which cannot be relinquished will be subject to vacation proceedings, and the petitioner will be so notified in writing by the City Engineer's Office.

A report and document are prepared to clear the encumbrance over the property and submitted to the Board of Public Works for approval. Petitioner will be notified of this action and should contact the City's Real Estate Division (Bureau of Engineering with regards to payment of document processing fees (these are set forth by the LA County Recorder) at (213) 485-5766.

The relinquishment which clears the future street or future alley encumbrance does not affect any other encumbrance over the property. Separate action(s) must be taken to clear any other easements.


